Waythrough launched in October 2024 following the merger of Humankind and Richmond Fellowship. Our vision is to break down the barriers that stop people getting the support they need to live a life they value. We tackle poverty and disadvantage in communities, through mental health, drug and alcohol, housing and related support.

We have almost 200 services around England – and nearly 3,500 amazing staff and volunteers who run them. Every year our services support around 125,000 people.



Bringing together two big organisations is not a small task and it'll take a while to fully integrate our systems, processes and approaches. That's
why you will notice the jobs here are still branded 'Humankind'. Next
year we'll be fully integrating our recruitment systems but for now they are separate.



Purpose of the Role

To have responsibility for the day-to-day management of assigned clinical service(s) (and related contractual KPIs).

Key Accountabilities

- 1. Work with Operational and Clinical colleagues to ensure good integrated governance, effectiveness and best practice within the service.
- 2. Provide clinical leadership to clinicians, including prescribers, to inform and influence clinical culture, quality and standards, and implementation of clinical models relevant to local site e.g. Hepatitis C treatment pathway, mental health pathway, pregnancy pathways.
- 3. Alongside other clinical site leads, and the Clinical Services Lead, support cross cover across sites to ensure clinical care is maintained during periods of illness or other staff shortages.
- 4. Facilitate clinical pathways between relevant local hospitals, Primary Care and Specialist Services for the referral and treatment of those who use our services.
- 5. Support on clinical recruitment, selection, induction, training, appraisal, disciplinary and grievance procedures, as appropriate.
- 6.Prescribe medication for those who use our services requiring prescribed interventions, in line with Humankind medicine management policies and governance procedures.
- 7.Deliver health promotion and harm reduction interventions in a person-centred manner (e.g. safer sex, contraception, nutrition and healthy living).
- 8. Promote and ensure clinical consistency throughout the services, according to local and national clinical processes.



- 9. Contribute to the maintenance of service user clinical databases; co-ordinate data entry and retrieval searches and reports to meet the internal and external service requirements as appropriate and ensuring data security at all times.
- 10. Manage, mentor, coach and ensure the development of staff, including volunteers and students. This involves carrying out performance & development reviews (PDRs), clinical supervision and providing IP training.
- 11. Support clinical team members in their role/s, including where they hold lead responsibilities (e.g. health and wellbeing assessments, community detoxifications).
- 12. Provide clinical support and supervision to allocated team members and to the wider alcohol and drugs recovery services commissioned in your area.
- 13. Provide advice and support to all team members in the management and care of service users including adjudicating on decisions to place service users on a treatment break, ensuring protocol is followed with a focus on safety.
- 14. Provide training on alcohol and drug related topics to internal staff, and external partner agency staff as required by the service's leadership.
- 15. Attend and present case studies at Case Conference and/or relevant professional meetings.
- 16. Participate in the review of, and facilitate the implementation, of strategies, policies and guidelines relating to clinical practice, where appropriate. This includes developing local variations in policies and guidelines (ensuring sign off by the author).
- 17. Participate in team and service wide performance evaluation (including identification of service gaps/deficiencies) and formulate/support appropriate remedial action.
- 18. Participate in the audit process and promote service wide or local clinical audit and implement findings/changes where indicated.
- 19.Review all deaths in service and participate in the process for investigation, ensuring learning points are implemented across the service via TADS (Training and Development Sessions), clinical audit and direct communication with staff.



- 20. Work with the team to ensure all standards required by the Care Quality Commission CQC are met and maintained.
- 21. Contribute to the development of joint working with external local partner and provider organisations, as appropriate, and offer clinical advice/support to partner agencies as requested.
- 22. Where included in the contract, support primary care and pharmacy services.
- 23. Support development of the programme for Peer Supervision and deliver teaching/training outside the service, as agreed with the Clinical Department.
- 24. Undertake continuing professional development including participating in clinical supervision, performance and development reviews and attending training as/when required.
